Architectural Description

Site Description: This property is located on the northeast corner of North Kent Street and East Piccadilly Street. The level lot features a commercial building that fronts a public concrete sidewalk. The commercial building takes up the entire property, so there is no yard. This building is bounded by commercial buildings.

Secondary Resource Summary: There are no secondary resources associated with this property.

Primary Resource Description: This two-story commercial building has a rectangular plan and is set on a solid concrete-block foundation. It is two bays wide and three bays deep. The masonry structure is constructed of rock-faced, concrete blocks and is capped by a hipped roof covered in standing-seam metal. The roof features overhanging eaves and an interior brick chimney. The main entrance is inset at the southwest corner of the building. The single-leaf entry holds a paneled wood door with one light and features a one-light transom. The second story of the façade (south elevation) and west (side) elevation of the commercial building is fenestrated with 2/2, double-hung, wood-sash windows. The façade and west (side) elevation is also fenestrated on the first story with paired one-light fixed windows with transoms and a row of four one-light, fixed windows. A small window opening on the first story of the west (side) elevation is partially obscured by an air-conditioning unit. Another air-conditioning unit, located immediately to the north, pierces the wall. All windows are enclosed with square-edged wood surrounds and feature rock-faced lintels. A single-leaf entry with a wood door is located in the northern end of the west (side) elevation. It features a bind transom and has a square-edged wood surround. A shared, rock-faced lintel connects the entry with a paired one-light, fixed window with narrow one-light transom.

A one-story, two-bay addition, constructed circa 1930, is located on the north (side) elevation. Constructed of concrete blocks, the addition is capped by a shed roof covered in metal. The west (front) elevation of the façade is fenestrated by a double-leaf entry and a single-leaf entry. Both entries have flush wood doors and are protected by a single, metal awning.

Significance Statement: This building is representative of commercial architecture constructed in the City of Winchester in the first part of the twentieth century. The building is not noted on Sanborn Fire Insurance maps in 1908, but is shown on the 1912 map. Based on map research and the building's form and materials, it was given a circa 1915 construction date. The building retains a high level of integrity of design, material and workmanship, despite minor alterations. A modest addition is located at the rear of the building and does compromise the integrity of the main block. The location, setting, feeling and association have not been compromised. Therefore, the commercial building qualifies under Criteria A and C as a contributing resource in the Winchester Historic District.

Architectural Description

Site Description: This property is located on the north side of East Piccadilly Street, just east of its intersection with North Kent Street. The commercial building is on a level lot and is bounded by commercial buildings. The building is adjacent to the public concrete sidewalk, with no setback.

Secondary Resource Summary: There are no secondary resources associated with this property.

Primary Resource Description: This one-story, two-bay commercial building has a rectangular form and is set on a solid foundation. The building is clad in stretcher-bond brick veneer and has a flat roof with a parapet wall that features a cornice of basket-weave brick. Another architectural feature of the roofline is the parapet piers with a corbeled base. Basket-weave brickwork is also found under sill of the storefront window. Fenestration on the façade includes a one-light, storefront window with a twenty-two-light transom, and a single-leaf entrance that holds a paneled wood door with one-light. It is topped by an eight-light transom. On the western end bay is a roll-up, wood garage door with twelve lights. This structure has similar scale and architectural detailing as 206 and 208 East Piccadilly Street, which were constructed after 1947. Although these building were constructed at different times, these resources read as one building.

Significance Statement: This commercial building is representative of the architecture constructed in the second quarter of the twentieth century in the north section of the city. It mimics the design of the building located at 204 East Piccadilly Street. Based on the commercial building's form and materials, as well as map research, it was constructed circa 1950. The building retains a high level of integrity of design, material, workmanship, location, setting, feeling and association. Therefore, the commercial building qualifies under Criteria A and C as a contributing resource in the Winchester Historic District.

Architectural Description

Site Description: This commercial building fronts the concrete sidewalk and is set on a flat lot.

Secondary Resource Summary: There are no secondary resources associated with this property.

Primary Resource Description: Set on a solid parged concrete block foundation, this one-story, two-bay commercial building has a rectangular plan. The building is masonry construction of parged concrete block and has an exterior brick chimney. The roof is flat and features a stepped parapet on the side (southeast) elevation. The building is fenestrated with a large one-light wood storefront window and a single-leaf wood door with lights and a one-light wood transom with a .

A one-story addition, constructed circa 1960, is located on the rear (northeast) elevation and is constructed of six-course American-bond brick. The shed roof is covered with standing-seam metal and features a stepped parapet. The addition is fenestrated with metal casement windows with rowlock sills and a two-bay wood garage door on the rear (north) elevation.

Significance Statement: This building is representative of the commercial architecture constructed along East Piccadilly Street in the City of Winchester during the second quarter of the twentieth century. Based on a site visit and Sanborn Fire Insurance Maps, this building was constructed circa 1950. The building retains its integrity of design, materials and workmanship. These aspects contribute to integrity location, setting, feeling, and association. Therefore, this building is a contributing resource to the Winchester Historic District under Criteria A and C.
