## Old Hospital Site Development

Preservation of Historic Winchester has been following the Conditional Use Permit waivers for the former Winchester Memorial Hospital site redevelopment. As we were in the 1990 rezoning, PHW remains concerned about the future impact development of this site will have on the surrounding historic neighborhood. We hoped in 1990 that “all future use of the old hospital structure and the area around it be compatible with the residential neighborhood.” The building reduction and additional green space with mature trees facing Stewart and less intensive medical use has been a welcome change and become the “new normal” for the residents.

Preservation of Historic Winchester supports the efforts of neighborhood residents who ask that any redevelopment of the old hospital site be done with respect for the history and carefully crafted zoning of the area. In 2016, this area was recognized as a National Register Historic District – as PHW hoped would happen in 1990 – with many of the late 19th and early 20th century homes lining the streets in much the same way they did in 1905 when the first hospital structures were built on this site. These were the homes built in large part for doctors, dentists, and nurses, and many of these buildings are still occupied by those same groups of medical service workers. To say this neighborhood is intact in architecture, character, and historic use is almost an understatement. While some historic structures were demolished years ago for hospital expansion, many more remain, contributing to the proud architectural heritage of Winchester.

We struggled with some of these same issues when the hospital moved in 1990. A primary argument made then still applies: Keep the site viable in health-related uses, but do not further destroy the historic fabric of the neighborhood. The core idea of adaptive reuse and new construction for assisted living at 333 West Cork Street is not bad, nor incompatible with the historic use of the site. As we cautioned in 1990,

however, “a delicate balance must be struck in order to preserve one of Winchester’s finest residential neighborhoods and keep the site viable. Medical related services are a natural use, but they should be restricted so the use does not impede on the neighborhood or compete commercially with other sections of the city.”

The Hospital Services zoning overlay was created with protections against excessive height, density, bulk, and width to lessen future development’s impacts on this historic neighborhood. We ask that Council honor those same safeguards today. ◆

- Have a fun, paid experience.

Applicants must be 18-35 years of age, a United States citizen or legal resident, and be in possession of a certificate of release or discharge from active duty with a discharge status of honorable or general under honorable conditions. ## Limestone Book Progress Update

Since January, a number of PHW volunteers have been looking over the resetting and editing of the *Limestone, Sycamores & Architecture* book. As we noted last newsletter, the image clarity was our highest priority. A slightly used copy of the book was unbound and scanned to capture the original images digitally. By unbinding, we were able to lessen most of the concerns about altering the photographic composition of James Morrison’s work. The text also remains mostly the same, with some light editing to bring the text in line with modern style and research guidelines.

As of the time of writing, we are currently updating the appendix to take into account the updated period of significance and expansions of Winchester’s National Register Historic District and individual nominations. While we do not have a timeline yet for copies to be in hand, the book is largely retyped, reset, updated, and in the final stages of internal approval. ◆

- **Elsie M. Rosenberger Award:** For the unsung volunteer or volunteers who selflessly contributed to the activities of PHW.
- **Ben Belchic Award:** For significant contribution to understanding Winchester's history.
- **Carroll H. Henkel Award:** For outstanding leadership for historic preservation in the Winchester-Frederick County area.
- **Patron's Award:** For that person or business who has been an outstanding supporter of the goals and programs of PHW.
- **Lifetime Achievement:** For a person who has worked for the goals and programs of PHW over many years.

**Award of Merit:** Houses or buildings whose renovation contribute to improving the character of their neighborhoods and maintaining the overall historic fabric of the city.

## Bough & Dough Shop

PHW was delighted with the new format of the Shop in 2018, and it seems you enjoyed it as well! Last year, we hosted 23 artists and 3 nonprofits in the Hexagon House. As you know, we regularly ask for feedback on the shop from our guests, and we felt it was more important than ever in 2018 given that this was a major overhaul of the shop.

It seems this approach worked out as we hoped. For the first time since we have been collecting information, feedback for the shop was overwhelmingly positive instead of mixed or negative. Shoppers appreciated the increased hours, larger floor space, and the variety and larger number of artisans we were able to accommodate.

A combination of factors this year also made checkout a "no stress" situation for the

first time in recent memory. It seems we finally had the perfect combination of hardware, internet/GPS stability, and a new (though labor intensive) digital item catalog that helped us accurately record sales for each artist. There was of course still some slowdown as we hand wrote our sales receipts, but by extending the duration of the Shop, we never experienced the crushing lines of shoppers that were common in past years.

Applications for artists are open now through October 31, and if you are thinking of joining the shop, we recommend applying early—at least half of our spaces are spoken for at this time.
